## Whole Turkey – Grade ‘A’ PLU 70012

### 1. Product is slaughtered under CFIA inspection:

All suppliers used are Federally Registered Canadian establishments or USDA approved facilities. These poultry slaughter and processing establishments have provided letters of guarantee to verify compliance with the “USDA Pathogen Reduction and HACCP Systems: Final Rule, Water Retention Protocol and have confirmed compliance with the Safe Food of Canadians Act Regulations”.

### 2. Raw Poultry Meat Microbiological Specifications (at time of packing):

- Total Plate Count: 500,000 cfu/g
- Coliform: 1000 cfu/g
- E. coli 100 cfu/g

### 3. Physical Specifications:

Standard appearance of turkey – Well shaped whole bird with even fat covering and neck and feet removed, includes giblets (heart, liver and neck), no disjointed or broken bones, no missing parts, no blood clots, bruises / discolouration, maximum coverage with skin, no pin feathers:

Product will be fresh or frozen and wholesome, with no obvious odour and free from visible contamination

Targeted based on live weights and verified based on dressed weights at time of packaging:  
5-7kg, 11.0-15.4lb

### 4. Shelf Life: from slaughter date

- Direct contact with meat: Vacuum Bags (CFIA approved food grade material)
- Non-direct contact: corrugated box, band-strapped and/or tape-sealed

- Meat Inspection Legend
- The day, month and year the product was produced, i.e. Julian Date format, (day-of-year, for example: 9221 = Aug 09) under the PLU (product) code, and YEAR, MONTH, DAY in the bar code, for example: 190809 = Aug 09, 2019.
- Code marks – UCC / EAN Code 128 Bar Code

- Moisture retention statement
