Pepperoni Calzone Sensory Requirements

- **Appearance**

- **Microwave Heated Exterior:** Slightly irregular, crescent shape with all surfaces having a light, visible sprinkle of parsley/oregano/cracker or bread crumbs/grated cheese. Top/bottom surfaces are light golden brown color.
Microwave Heated Interior: Filling is layers of folded medium brown red pepperoni slices with creamy off white cheese blend and bright orange grease ring between pepperoni/bread. Middle/folded section has more filling than the edges. Pepperoni and cheese are evenly dispersed and remain tucked inside the bread as pieces are cut. Thin layer of top-side crust evident with very moist bottom side.
- **Oven Heated Exterior:** Slightly irregular, crescent shape with all surfaces having a light, visible sprinkle of parsley/oregano/cracker or bread crumbs/grated cheese. Top/bottom surfaces are medium golden brown color.
Oven Heated Interior: Filling is layers of folded medium brown red pepperoni slices with creamy off white cheese blend and bright orange grease ring between pepperoni/bread. Middle/folded section has more filling than the edges. Pepperoni and cheese are evenly dispersed and remain tucked inside the bread as pieces are cut. Top and bottom crust surfaces evident without gumminess.

- **Texture**

- **Microwave Heated:** Middle section has high resistance on the initial bite with a slightly tough/slightly dry chewiness at the 5th chew-down. Edges are slightly tougher. Filling has slightly resistant and chewy pepperoni slices with creamy, soft (mouthfeel)cheese. Bottom crust is moist.
- **Oven Heated:** Middle section bread has slight resistance on the initial bite with a slight chewiness at the 5th chew-down. Edges are slightly resistant, moist and tender. Filling has a slight resistance and chewy pepperoni with creamy, soft cheese blend. Bottom crust is slightly chewy.

- **Flavor (Aroma & Taste)**

- **Microwave Heated:** Aroma is very mild caramelized bread, oregano and parmesan/romano cheese. Edges and middle sections have a very slight caramelized bread flavor with the middle section having a high pepperoni flavor, moderate saltiness, slight cheese flavor and moderate red pepper sicy heat.
- **Oven Heated:** Aroma is a mild caramelized bread with mild oregano and parmesan/cheese blend. Edges and middle sections have a slight caramelized bread flavor with the middle section having a moderate saltiness, high pepperoni flavor, slight cheese flavor and moderate red pepper sicy heat.
